**ORDER**

**Facts:**

1. The appellant filed RTI application dated 21.03.2014 seeking information on 13 points regarding action taken on his complaint 24.06.2013 against Amar Chand H.C (RPF) who was accused in the FIR No. 194/13 dated 13.06.2013 PS Sadar (W) Jaipur etc.

2. The CPIO responded on 09.04.2014. The appellant filed first appeal on 08.05.2014 with the First Appellate Authority (FAA). The FAA responded on 10.11.2014, 26.11.2014. The appellant filed appeal on 16.02.2015 before the Commission with the plea that the sought for information has not been provided to him.

**Hearing:**

3. The appellant and the respondent both participated in the hearing.

4. The appellant stated that the sought for information has not been provided to him. The appellant stated that he has been provided irrelevant information. The appellant stated that the sought for information is not personal information of third party. The appellant stated that he is seeking action taken on his complaint against the third party.i.e Shri Amar Chand.

5. The respondent stated that the appellant has been replied to vide letter dated 09.04.2014. The respondent stated that the available information on point on. 1 to 4 has been provided to the appellant. The respondent stated that the information with regard to point no. 7 to 11 is personal information and point no. 12 is a question in nature, which is not required to be answered under the RTI Act. The respondent stated that third party has denied to disclose his personal information vide letter dated 28.04.2014, a copy of the said letter has been provided to the appellant.

6. The respondent stated that the action taken on appellant's complaint has been informed to the appellant that the inquiry was conducted and allegation/charges were not proved.

**Discussion/ observation:**

7. The inquiry report and Income Tax details of third party is personal information. The posting details etc. with respect point no. 7-10 can be provided to the appellant, as these are in the nature of public information.

**Decision:**

8. Respondent is directed to provide information to the appellant on point no. 7-10 in context of his RTI application within 30 days of this order.

The appeal is disposed of. Copy of the order be given to the parties free of cost.
