ORDER

1. Shri Nand Kishore Arora filed an application dated 11.05.2015 under the Right to Information Act, 2005 (RTI Act) before the Central Public Information Officer (CPIO), West District, Delhi Police seeking information on three points pertaining to certified copies of the complaints/letters submitted by his daughter-in-law from 06.03.2015 onwards in PS Uttam Nagar.

2. The appellant filed a second appeal dated 28.10.2015 before the Commission on the grounds that he has not been provided complete information either by the CPIO or the First Appellate Authority (FAA).

Hearing:

3. The appellant Shri Nand Kishore Arora was not present despite notice. The respondent Shri K. P. Malik, Inspector, West District, Delhi Police was present in person.

4. The respondent submitted that the appellant was informed vide letter dated 10.06.2015 that the information in respect of point nos. 1 and 3 of the RTI application can be obtained on payment of the requisite fee. The respondent in respect of point no. 2 of the RTI application submitted that appellant had sought details of all the PCR calls made by his daughter-in-law. However, the same could not be provided as there was no mention in the RTI application about the mobile number from which the PCR call was made or about the complainant. The respondent also stated that the appellant in his first appeal has raised the issue with regard to copy of DD/GD entries as sought in point no. 3 of the RTI application. However, no DD entries are made in respect of the complaints received and only GD entries in respect of the complaints received are made, which have been provided to the appellant. Hence, no further information remains to be provided on the part of the respondent.

Decision:

5. The Commission, after hearing the submissions of the respondent and perusing the records, observes that due information as per available records, has been provided to the appellant by the respondent. Hence, no further action is required in the matter.

6. With the above observations, the appeal is disposed of.
7. Copy of the decision be provided free of cost to the parties.
