**ORDER**

1. Shri Neeraj filed an application under the Right to Information Act, 2005 (RTI Act) before the Central Public Information Officer (CPIO), South West District, Delhi Police seeking certain information related to case FIR No.115/13 dated 21.04.2013 U/S 302, 201, P.S. Chhawla, New Delhi.

2. Shri Neeraj filed a second appeal dated 08.09.2015 before the Commission on the grounds that the CPIO had denied the information under Section 8(1)(h) stating that the case is pending trial before Hon'ble Court and when directed by the First Appellate Authority (FAA) to reconsider the RTI application and provide comprehensive information, again denied the information stating that the case is pending trial in the Hon'ble Court and that the information sought cannot be provided at this stage without permission of the Court. The appellant requested the Commission to provide the information sought by him.

**Hearing:**

3. The appellant Shri Neeraj was not present despite notice. The respondent Shri Anand Prakash, APIO, South West District, Delhi Police was present in person.

4. The respondent submitted that the CPIO vide letter No.31.07.2015 had informed the appellant that the case FIR No.115/2013 is pending trial in the court vide RC No.228/21/13 since 18.07.2013. The respondent further submitted that the FAA vide order dated 10.07.2015 had directed the CPIO to reconsider the RTI request of the appellant and provide a comprehensive information on the RTI application to the appellant. The respondent also submitted that in compliance with the FAA's order dated 10.07.2015, information was provided to the appellant vide letter dated 13.11.2015.

**Decision:**

5. The Commission, after hearing the submissions of the respondent and perusing the records, observes that due information has been provided to the appellant. Hence, no further action of the Commission is required in the matter.

6. With the above observations, the appeal is disposed of.
7. Copy of the decision be provided free of cost to the parties.
