ORDER

Facts:

1. The appellant filed an RTI application dated 6-10-2014 requesting for: copy of due and drawn statement; the drivers of Gangapur City headquarters who were transferred after 1-1-2006 had got arrears about six months back, but the appellant and 20 other employees had not got the arrears. The appellant wanted to know as to why the arrears have not been paid to him, how the arrear was paid to one employee after September 2014 though it was not paid to 20 employees for the last six months, what action has been taken on the arrear preparing employee though the competent authority ordered for early preparing of the arrear. Further, it has come to the notice of the appellant that the said amount has been disbursed fraudulently against fake signatures of unknown persons and the papers have been deposited in the

office of competent authority. The appellant wants a copy of the papers which have been deposited and other related issues.

2. The PIO responded on 20-10-2014. The appellant filed an appeal before the FAA on 30-10-2014. The FAA responded on 22-11-2014. The appellant filed a second appeal before the Commission on 19-2-2015.

Hearing:

- 3. Both the parties participated in the hearing through video conferencing.
- 4. The appellant stated that he has received information on points 1 to 7 of the RTI application. In so far as points 8 to 10 are concerned, he has not received the information. On point 8, the appellant stated that respondent has not provided him the list of persons to whom the award was not given (although their names were in the nominated list). On point 9, the appellant stated that CTCC/GGC has sent a list of persons who have received the award containing their signature. The appellant said that this list has not been provided to him. The respondent stated that the list being sought is not clear.
- 5. On point 10, the appellant stated that the respondent has not informed him about the action taken on the persons who were responsible for corruption.
- 6. The respondent stated that they will provide information to the appellant on point 8 of the RTI application.
- 7. As regards point 9 is concerned, the respondent stated that they will offer inspection to the appellant who may take copies of relevant documents that he has sought.
- 8. The respondent stated that there is no information on corruption with him, in response to point 10, as referred to in para 5.

Discussion/Observations

9. The respondent should provide information to the appellant on point 8 of the RTI application within 30 days.

10. On point 9 of the RTI application, the respondent shall offer inspection to the appellant within 30 days and give him copies of information sought for in RTI request, free of cost.

Decision:

11. The respondent is directed to take action as per paras 9 and 10 above.

The appeal is disposed of. Copy of decision be given fee of cost to the parties.
