ORDER

1. Shri Sandeep Kumar filed an application dated 18.06.2015 under the Right to Information Act, 2005 (RTI Act) before the Central Public Information

Officer (CPIO), Prime Minister's Office (PMO) seeking information on three points pertaining to status report of his three letters dated 07.05.2015, 22.05.2015 and 17.03.2015 relating to social and cultural campaigns. The CPIO, PMO vide letter dated 26.06.2015 transferred the RTI application relating to point no.1 to the Revenue Department. The CPIO, Department of Revenue vide letter dated 08.07.2015 transferred the RTI application to Central Excise (Delhi Zone).

2. The appellant filed a second appeal dated 28.10.2015 before the Commission on the grounds that he has not been provided any information.

Hearing:

3. The appellant Shri Sandeep Kumar and the respondent Shri Sanjay Sundriyal, Superintendent, Central Excise, Delhi – 1 were present in person.

4. The respondent submitted that the CPIO, PMO vide letter dated 26.06.2015 transferred the RTI application relating to point no.1 to the Revenue Department. The CPIO, Department of Revenue vide letter dated 08.07.2015 transferred the RTI application to Central Excise (Delhi Zone). The respondent further stated that a reply of the RTI application was provided to the appellant vide letter dated 15.09.2015. The respondent requested the Commission to grant him some more time to make additional submissions in the matter.

Interim Decision:

5. The Commission considered the request of the respondent and adjourns the matter to **10.01.2017 at 1:00 p.m.**
