**Information sought and background of the case:**

The appellant vide RTI application dated 07.09.2015 sought information under 6 points regarding seniority list of Junior Engineers (Civil) in Municipal Corporation of Delhi/North Delhi Municipal Corporation.

CPIO vide letter dated 07.12.2015 furnished point wise information as available on record. Feeling aggrieved the appellant approached the Commission.

**Relevant facts emerging during hearing:**

The appellant is absent while Respondent has appeared and states that information a available has been provided. It is noted that the information furnished by Respondents addresses the queries 1 and 4 of the RTI application. The Respondent states that since information sought is spread over 60 JEs and query number 2 relates to three different zones of MCD viz. NDMC, SDMC and EDMC, collating such information is a time consuming and uphill task. Apart from the trifurcation of the zones, the promotions are

done from the level of JE to AE at NDMC, and posting thereafter is done at any of the three zones, hence it is difficult to locate the information sought.

**Decision:**

After hearing the Respondents and perusal of record, the Commission directs the Respondent to furnish information about the total number of chargesheets issued by the Respondent in response to query number 3 without revealing name, designation or any other particular of the chargesheeted employee. The Respondent is directed to provide information against query number 5 in so far as number of candidates promoted so far from the said seniority list of Junior Engineers (civil). The Commission directs the Respondent to furnish the aforementioned information within three weeks of receipt of this order.

The appeal is disposed of with the above directions.
