**ORDER**

**Facts:**

1. The complainant filed RTI application dated 24.05.2013 seeking information on 6 points regarding: respondent's reply to BCD notice regarding complaint against Sh. Praveen Swarup; proof of respondent having served the notice; proof of complainant's request to file rejoinder, etc.
2. The response of CPIO is not on record. The complainant filed first appeal dated 14.07.2013 with First Appellate Authority (FAA). The response of FAA is not on record. The complainant filed complaint on 21.08.2013 before the Commission.
3. The Commission vide letter dated 28.10.2014, directed the respondent to furnish the information.
4. The respondent vide letter dated 14.11.2014, has given point-wise reply to the complainant.

**Hearing:**

5. The complainant was personally present in the hearing. The respondent was absent.

6. The complainant referred to his RTI application dated 24.05.2013 and stated that no information has been provided to him till date by the respondent.

7. During the hearing, the complainant raised issues regarding his court cases and stated that a lawyer has appeared in case without his authorization. He stated that false affidavits had been filed by the lawyers in the case. The Commission advised the complainant that these matters have to be raised in appropriate forum.

**Discussion/ observation:**

8. From the perusal of the records, it is seen that the respondent vide letter dated 14.11.2014 had given point-wise reply and full information to the complainant on his RTI application with a delay.

**Decision:**

9. The respondent is directed to show cause in writing that why action should not be taken against him for not furnishing information to the complainant within stipulated period of time and not attending the hearing in the Commission, within 15 days from the date of this order.

10. The Deputy Registrar is directed to fix a hearing in the matter after 15 days for compliance.
