ORDER

1. Shri Bhagwan M. Karia filed an application dated 05.02.2014 under the Right to Information Act, 2005 (RTI Act) before the Central Public Information Officer (CPIO), Central Information Commission (CIC) seeking information/documents on six points pertaining to non-compliance of Commission Order No. CIC/BS/A/2012/001802/4068 dated 05.12.2013,

including status of his letter dated 05.02.2014 to Shri A.K. Jha Dy. Registrar of CIC, (2) names and designation of the officers who have been looking after his letters/correspondences, their final comments on it and the status of it and (iii) reasons why his letters are not responded.

2. The appellant filed a second appeal before the Commission on 30.10.2014 on the grounds that the Order No. CIC/BS/A/2012/001802/4068 dated 5th December, 2013 of the Commission has not been complied with so far.

Hearing:

3. The appellant Shri Bhagwan M. Karia attended the hearing through audio. The respondent Shri R.L. Gupta, Deputy Registrar and CPIO, CIC was present in person.

4. The appellant submitted that in compliance with the order of CIC dated 05.12.2013 he had attended the meeting with CPMG, Maharashtra Circle, Mumbai on 10.02.2014.

6. The respondent submitted that the second appeal in the matter has already been heard by the Commission on 16.05.2016 in file no. CIC/YA/A/2014/002183/SB.

Decision:

7. The Commission, after hearing the submissions of both the parties and perusing the records, observes that a similar matter has already been heard by the Commission on 16.05.2016 vide file no. CIC/YA/A/2014/002183/SB. The decision taken in that matter will apply in this case also.

8. With the above observations, the appeal is disposed of.
