**Shri Ramesh Chandra v. The Central Public Information Officer (CPIO),
Ordnance Clothing Factory, Shahjahanpur**

ORDER

1. The complainant filed an application under the Right to Information Act, 2005 (RTI Act) before the Central Public Information Officer (CPIO), Ordnance Clothing Factory, Shahjahanpur, Uttar Pradesh, seeking information on four points, including, inter alia, (i) whether the General Manager had prepared any agreement note in Case No. VIG/162-e/NIE/34/90 (14) dated 26.07.1990 and if yes, then a copy of the said note, and (ii) a copy of the report of the inquiry conducted by the Inquiry Officer in the aforesaid matter.

2. The complainant filed a complaint before the Commission on the grounds that he was not satisfied with the response of the CPIO. The complainant is also aggrieved with the non-compliance of the Order of the First Appellate Authority (FAA). The complainant requested the Commission to direct the CPIO to provide the information sought for by him.

Hearing:

3. The complainant Shri Ramesh Chandra and the respondent Shri S. S. Doiphode, Joint General Manager (JGM) and CPIO, Ordnance Clothing Factory, Shahjahanpur, attended the hearing through video conferencing.

4. The complainant submitted that the requisite information, in response to his RTI application, was not furnished by the respondent organization.

5. The respondent submitted that the second appeals in two similar matters have already been heard and disposed of by the Commission vide Orders dated 22.08.2016 and 05.10.2016 in Decision No. CIC/CC/A/2014/002755/DP and CIC/RM/C/2014/000589-AB respectively. The respondent further submitted that in compliance with the said Order of the Commission dated 22.08.2016, point wise and complete information was provided to the complainant vide letter dated 05.09.2016.

Decision:

6. The Commission finds that the second appeals in two similar matters have already been heard and disposed of by the Commission vide Orders dated 22.08.2016 and 05.10.2016 in Decision No. CIC/CC/A/2014/002755/DP and CIC/RM/C/2014/000589-AB respectively. Hence, no further intervention of the Commission is warranted in the matter.

7. With the above observations, the complaint is disposed of.
