Information sought and background of the case:

The appellant vide RTI application dated 12.10.2015 sought information under 3 points regarding construction of illegal building on the back lane road meant for the use of public. CPIO did not respond to the RTI application. The appellant preferred first appeal but the same remained unheard. Feeling aggrieved the appellant approached the Commission.

Relevant facts emerging during hearing:

The appellant is absent despite notice. The respondent is present and heard. Respondent submits that the RTI application was transferred to office of EE(B)/KBZ, North DMC and the same was received on 01.01.2016. He states that information sought was furnished to the appellant on 06.01.2016 thereby intimating him that no complaint was received in the building department against the alleged unauthorized construction behind plot No.- 2151/9, Shadi Khampur, New Delhi and the property is not booked for any

unauthorised construction. He places a copy of the reply dated 06.01.2016 before the Commission. Perused and taken on record.

Upon a query from the Commission if any action is being contemplated to ascertain the factum of the alleged unauthorized construction as enumerated in the RTI application, the respondent seeks time to check the record.

Decision:

After hearing respondent and perusal of record, the Commission finds the reply of CPIO in order. However, taking note of the averments made in the RTI application, the Commission directs the CPIO to take cognizance of the RTI application as complaint and initiate action in accordance with law.

The appeal is disposed of accordingly.
