FACTS:

- I. Vide RTI application dated **16.08.2010**, the appellant sought information on **sole issue**.
- II. CPIO, response is not on record.
- III. The First Appeal (FA) was filed on **21.10.2011**, as desired information not provided.
- IV. First Appellate Authority (FAA), order is not on record.
- V. Grounds for the Second Appeal filed on **22.11.2011**, are contained in the Memorandum of Second Appeal.

HEARING

Appellant opted to be absent despite of our due notice to him. Respondents appeared before the Commission personally and made the submissions at length.

DECISION

At the outset, it is stated here that the concerned registry has wrongly opened two files having the same bearing no. **CIC/SS/A/2012/000824**, dealing with the same subject. It is needless to mention here that one File has already been decided on **25.04.2012** by Smt. Sushma Singh, then Hon. Central Information Commissioner. Further, this order was, lateron, merged with another order dated 07.06.2013, dealt in file bearing no. **CIC/SS/A/2012/002359**. However, the other file bearing no. **CIC/SS/A/2012/000824**, was kept pending for the hearing in that Sub-Registry of Smt. Sushma Singh, then Hon. Central

Information Commissioner, which was handed over to this Sub-Registry only on **27.07.2016** for taking necessary action.

2. The Commissioner heard the submissions made by respondents at length. The Commission also **perused** the case-file **thoroughly**; specifically, **nature of issues** raised by the appellant in his RTI application dated **16.08.2010**, other material made available on record and also the grounds of memorandum of second appeal.
3. In view of the **position** above and in the **circumstances** of case, the Commission feels that it would be **appropriate and even justified** to dispose of the appellant's captioned second appeal in terms of its earlier order dated **25.04.2012** passed in the appellant's earlier second appeal based on appellant's same RTI application dated **16.08.2010**. Thus, the appellant's instant second appeal is hereby disposed of in terms of Hon. CIC's earlier order dated **25.04.2012** passed in **file no. CIC/SS/A/2012/000824**.

The Appeal is disposed of accordingly.
