**Facts:**

## Order

**Appellant** : **Present**

During the hearing the appellant submitted that he was not satisfied with the reply received from the respondent. The PIO handed over a written submission during the hearing.

On perusal of the case record, it was seen that the reply provided by the PIO to the appellant was incomplete. The Commission observes that certified copies of complete note sheet, correspondence etc relating to the action taken on letters dated 05.03.2015 and 18.05.2015 should have been provided to the appellant by now.

The DPG and CPIO, Railway Board shall provide complete information in the form of certified copies of the documents mentioned above within 15 days of the receipt of this order free of charge u/s 7(6) of the RTI Act, to the appellant. A compliance report shall be submitted by the PIO, thereafter to the Commission for record within a further period of 7 days.

*With the above direction, the appeal is disposed of.*
