**Shri Amit Tripathi v. The Central Public Information Officer (CPIO),
Ordnance Equipment Factory**

ORDER

1. The appellant filed an application under the Right to Information Act, 2005 (RTI Act) before the Central Public Information Officer (CPIO), Ordnance Equipment Factory (OEF), Kanpur, seeking information including, inter alia, (i) the details pertaining to the permanent addresses of one Shri B. P. Mishra, Additional General Manager and Shri K. N. Arya, Addl. GM and Shri M. C. Bala Subramanyam, Joint GM, as stated in their Service Books, and (ii) the details pertaining to the movable and the immovable assets of the aforementioned three officers along with whether the said officers have been coming to the office by using the government vehicles or their own means of transport.

2. The appellant filed a second appeal before the Commission on the grounds that he was not satisfied with the reply provided by the CPIO. The appellant is also aggrieved with the information furnished by the CPIO, OEF in compliance with the decision of the First Appellate Authority (FAA), OEF. The appellant requested the Commission to direct the CPIO to provide the information sought for by him.

Hearing:

3. The appellant, Shri Amit Tripathi was not present despite notice. The respondent Shri Ramji Gupta, Junior Works Manager (JWM) and CPIO, Ordnance Equipment Factory, Kanpur, attended the hearing through video conferencing.

4. The respondent submitted that vide the CPIO's reply dated 15.02.2016, point wise and complete information was provided to the appellant. The respondent further submitted that the FAA vide its Order dated 12.03.2016, had directed the CPIO, OEF, to provide the information sought for by the appellant. Therefore, in compliance with the decision of the FAA dated 12.03.2016 vide letter dated 09.04.2016, point wise and complete information was provided to the appellant. However, the appellant had preferred another first appeal dated 26.04.2016. In response to the first appeal dated 26.04.2016, the FAA vide its Order dated 25.05.2016, had endorsed the information furnished by the CPIO vide letter dated 09.04.2016.

Decision:

5. The Commission, after hearing the submissions of the respondent and perusing the records, observes that due information, in response to the RTI application dated 14.01.2016, has been furnished to the appellant by the respondent. Hence, no further action is required in the matter.

6. With the above observations, the appeal is disposed of.
