ORDER

Facts:

1. The appellant filed RTI application dated 15.05.2015 seeking certified copy of document related to the date of birth of the late former Prime Minister Shri Chandrasekhar.

2. The CPIO responded on 19.06.2015. The appellant filed first appeal on 27.06.2015 with the First Appellate Authority (FAA). The FAA response is not on record. The appellant filed second appeal on 21.01.2016 before the Commission with the plea that the sought for information has not been provided to him.

Hearing:

3. The appellant and the respondent both participated in the hearing.

4. The appellant stated that the Government of Uttar Pradesh has declared public holiday on 17.04.2015 as the birth anniversary of late former Prime Minister Shri Chandrasekhar. The appellant stated that he has been informed by the Prime Minister Office (PMO) that the date of birth of the Hon'ble former Prime Minister Shri Chandrasekhar is 01.07.1927, which is

as available on PMO website. However, the document related to the date of birth has not been supplied to him. The appellant stated that the birth anniversary of the Hon'ble former Prime Minister Shri Chandrasekhar should be celebrated on his correct date of birth.

5. The respondent stated that the appellant vide letter dated 06.10.2015 has been informed that the date of birth of the Hon'ble former Prime Minister Shri Chandrasekhar is 01.07.1927, as available on PMO website www.pmindia.gov.in. No documents certifying his date of birth are available in the record. The respondent stated the personal profile of the Prime Minister is prepared and uploaded on the website by his personal staff as per his directions. There is no requirement for the Prime Minister to submit his date of birth document in the Prime Minister Office.

Discussion/ observation:

6. The action/steps taken by the respondent in dealing with the RTI application is satisfactory.

Decision:

7. No action is required in the matter at the level of this Commission.

The appeal is disposed of. A copy of the order be given to the parties free of cost.
