**ORDER**

**Facts:**

1. The appellant filed RTI application dated 14.12.2014 seeking information on action taken on his letters dated 21.05.2014, 27.08.2014, 11.11.2014, 01.08.2014, 21.11.2014, 19.09.2014, 22.10.2014 and 10.07.2014
2. The CPIO responded on 23.01.2015 and 13.02.2015. The appellant filed first appeal on 16.02.2015 with the First Appellate Authority (FAA). The FAA responded on 13.03.2015. The appellant filed appeal on 22.04.2015 before the Commission with the plea that the sought for information has not been provided to him.

**Hearing:**

3. The appellant and the respondent participated in the hearing.
4. The appellant stated that the he is asking action taken on his 8 complaints/representations. The appellant stated that he has not been informed as to what is fate of his complaints. The appellant stated that respondent gave irrelevant reply that information is exempted under section 8(1)(j) of the RTI Act.

5. The respondent stated that the appellant has been replied to vide letter dated 13.02.2015 stating that the sought for information is exempted under section 8(1)(j) of the RTI Act. The respondent stated that they have received numerous letters from the appellant. The respondent stated that they do not always process such letters on file. In the case of letter dated 21.05.2014, the matter related to complaint against an officer. This was put up to ADRM, who ordered non disclosure under section 8(1)(j) of the RTI Act.

6 The appellant stated that he has not been provided noting/outcome of the complaint/representation.

**Discussion/ observation:**

7. If there is any file noting on action taken on complaint/representation that should have been provided to the appellant and if no action was taken, the appellant should have been informed accordingly.

**Decision:**

8. The respondent is directed to provide file notings on complaints, if there is any file noting on action taken on complaint/representation and if no action was taken, the appellant be informed accordingly within 15 days of this order.

The appeal is disposed of. Copy of the order be given to the parties free of cost.
