**Information sought and background of the case:**

The complainant vide RTI application dated 01.09.2015 sought information under 10 points regarding recommendation for re-employment of personnel in ICMR, after their retirement.

CPIO did not respond to the RTI application. Feeling aggrieved the complainant approached the Commission.

**Relevant facts emerging during hearing:**

The complainant is absent despite notice. The respondent is present and apprises the Commission that complainant sought information regarding re-employment of personnel in ICMR vide RTI application dated 01.09.2015. The respondent submits before the Commission that point wise information has already been provided to the complainant vide letter dated 08.10.2015, copy whereof has been placed on record before the Commission alongwith submission dated 02.11.2015.

**Decision:**

After hearing the respondent and perusal of record, the Commission finds that information sought has already been provided by the respondent. The complainant is not present to buttress his case. Hence, there is no need for any further action in this matter.

The complaint is dismissed accordingly.
