### **ORDER**

1. Shri Girish Prasad Gupta filed an application dated 09.01.2014 under the Right to Information Act, 2005 (RTI Act) before the Central Public Information Officer (CPIO), Central Information Commission (CIC) seeking information on four points pertaining to Dy. No. 181652 dated 14.11.2013, the total number of cases (Appeal & Complaints) registered and disposed of

by the Commission upto 2013, complete particulars of the Information Commissioners working in the Commission and copy of the guidelines issued by the Government of India for disposal of the work in the Commission in English.

**2.** The appellant filed a second appeal before the Commission on 14.05.2014 on the grounds that the information provided against point No. 2 is incomplete and the appellant is not able to access the website of the Commission and that on point Nos. 3 & 4, providing of the information has been intentionally avoided. The appellant requested the Commission to issue instructions to the CPIO to provide point-wise information, take disciplinary action against the respondent and award appropriate compensation to him.

**Hearing:**

**3.** The appellant Shri Girish Prasad Gupta was not present despite notice. The respondent Shri A.K. Sharma, CPIO, CIC was present in person.

**4.** The respondent submitted that point wise information was provided to the appellant vide letter 14.02.2014. The appellant was also informed that the appeals/complaints registered are available on the website of the Commission.

**Decision:**

**4.** The Commission, after hearing the submissions of both the parties and perusing the records, observes that information as held by the respondent had been provided to the appellant. Hence, no further action is required in the matter.

**5.** With the above observations, the appeal is disposed of.

**6.** Copy of decision be given free of cost to the parties.
