Information sought and background of the case:

Vide above mentioned RTI applications dated 11.02.2016, 09.05.2016 and 19.05.2016 the appellant sought information with regard to Shiv Vihar polyclinic, Veer Sawarkar Arogya Sansthan and Veer Sawarkar Polyclinic/Hospital in 3 different RTI applications respectively. In this, the appellant sought to know the cost of building, list of equipment and machinery purchased for the respective polyclinic, list of medical equipment bed etc., copy of tender floated for these items, items supplied and other relevant issues.

Having not received any response from the public authority, the appellant filed an appeal, which remained unheard. Feeling aggrieved, the appellant approached the Commission.

The RTI application dated 09.05.2016 was transferred by the PIO/Addl. MS, Swami Dayanand Hospital vide letter dated 12.07.2016 informed the

appellant that his RTI application had been transferred to the 1) PIO, Planning Deptt, Shahdara North Zone; 2) PIO, Medical, EDMC(HQ) and 3) PIO VSAS, Karawal Nagar by letter dated 24.05.2016. In the similar manner, PIO/Addl MS, Swami Dayanand Hospital vide letter dated 04.06.2016 transferred the RTI application to PIO, OIVS, EDMC and PIO, VSAS and informed the appellant about the transfer vide letter dated 12.07.2016.

Relevant facts emerging during hearing:

The Respondent, PIO, MS, Swami Dayanand Hospital appeared during the hearing and has submitted the same stance as already stated vide their letter dated 12.07.2016, addressed to the appellant.

Decision:

In view of the submissions of the Respondent/PIO, MS, Swami Dayanand Hospital, the Commission hereby directs the 1) PIO, Planning Deptt, Shahdara North Zone; 2) PIO, Medical, EDMC(HQ) and 3) PIO VSAS, Karawal Nagar to submit an explanation before the Commission as to why no information has so far been provided to the Appellant despite the lapse of a year since the RTI application was transferred to them. The three PIOs are also directed to provide information, as is in their custody respectively, in response to the RTI application. The information should be supplied within two weeks of receipt of this order and copy thereof marked to the Commission alongwith the Explanation for such inordinate delay in providing the information. The Commission shall initiate appropriate action against the three PIOs upon due consideration of their explanations.

The appeals are disposed of with the above directions.
