1. Appellant: Present.

Public authority: Mr. M. K. Aggarwal, AC and Mr. Raj Kumar, AC.

FACTS:

2. The appellant filed RTI Application seeking information pertaining to position of addition demand generated by defective- DVAT System Branch dated 15.6.2015 or 19.6.2015. He wanted to know the provisions under which de-sealing of business is done by enforcement officials of Delhi Trade and Tax Department on which CPIO asked him to visit the official website for information etc. The FAA directed PIO (system) to provide information on any additional demand DVAT System Branch dated 15.6.2015 or 19.6.2015 and PIO (Policy) to provide information on point no. 13. He directed PIO (Ward 94) and PIO (recovery) to provide information on latest status of recoveries made. He directed concerned PIO to provide information on points 7-11. Appellant filed second appeal before this Commission.

Decision :

3. The appellant complained that the though department has information they are denying the same, though the M/s Jackson Engineer Private Ltd is

registered, they are saying it is not registered (letter dated 21.03.2016 issued to the appellant). Mr. Anil Kumar Asstt. Commissioner (Policy) and PIO stated on 08.03.2016 that the Act & Rules and circulars are available on website.

4. The Commission gave an opportunity to the appellant to point out specific documents he required. He wrote 8 big paragraphs without specifying the documents. He presented clarificatory questions in form of demand for information which cannot be answered under RTI Act, hence, closed.
