CIC/VS/A/2015/001793:

During the hearing the respondent CPIO submitted that they had provided the requisite reply vide their letter dated 08.05.2015 in connection with the RTI the application dated 25.02.15. The appellant submitted he did not receive any reply from the respondent.

The respondent CPIO further submitted that records of 4th and 5th pay commission arrears are not available. The respondent CPIO is directed to affirm on affidavit the same fact to the Commission within 15 days of the receipt of the order with a copy endorsed to the appellant.

The respondent CPIO is directed to provide point wise reply complete in all respects to the appellant including certified true copy of the 6th Pay Commission arrears, free of charge, u/s 7(6) of the RTI Act within 21 days of the receipt of the order.

A compliance report with proof of despatch of the said reply to the appellant shall be submitted within 07 days thereafter to the Commission for record.

CIC/RK/A/2016/001001:

The appellant submitted he did not receive any reply from the respondent.

On perusal of the case record, it was seen that no information was provided to the appellant.

The respondent CPIO is directed to provide point wise reply complete in all respects to the appellant including certified true copies, free of charge u/s 7(6) of the RTI Act within 21 days of the receipt of the order.

A compliance report with proof of despatch of the said reply to the appellant shall be submitted within 07 days thereafter to the Commission for record.

With the above direction, the appeal is disposed of.
