During the hearing, it was observed that the Sena Bhawan transferred the said RTI application to the Respondent CPIO, Allahabad u/s 6(3) of the RTI Act. The appellant submitted that he did not get the requisite reply from the CPIO, Allahabad.

On perusal of the case record, it was seen that no information was provided by CPIO, Allahabad to the appellant. **A Show Cause Notice is issued to the then CPIO, Allahabad** for not furnishing the required reply to the appellant, especially as the matter is already two and half years' old. The said Show Cause notice is to be served through the present CPIO, Allahabad to the then CPIO, Allahabad.

The present CPIO, Allahabad is directed to provide point wise reply complete in all respect to the appellant within 21 days from the date of receipt of the order. Compliance report shall be submitted thereafter to the Commission for record.

The CPIO may note that non-compliance of this order may lead to penal action u/s 20(1) of the RTI Act.

The registry is directed to enclose a copy of the RTI application alongwith this order to the CPIO, Allahabad.

With the above direction, the appeal is disposed of.
