Information sought and background of the case:

Vide RTI application dated 08.07.2015, the appellant sought the following information:-

1.The copies of Official letters so far received by the Office of the Deputy Labour Commissioner, South, New Delhi-110062, and the copies so far issued/ communicated by this Labour Commissionerate, New Delhi-110062 , if any , to the:-

1. the Chief Secy to the GNCT of Delhi

- 2.The Labour Commissioner to the GNCT of Delhi
- 3.The Chief Secy to the Odisha Govt., BBSR
4. The Labour commissioner to the Odisha Govt., BBSR
- 6.Minister, Labour and Employment, Govt of India, New Delhi
7. The management of the P.K. Himatsingka & co., New Delhi

The CPIO replied vide letter dated 07.08.2015 requested to appellant to deposit requisite fee @2/- per page. Dissatisfied with response received from CPIO, the appellant filed first appeal. The First Appellate Authority vide letter dated 14.01.2016 directing the SPIO to furnish the requisite information within one week to the appellant alongwith photocopy of 141 pages subject to the depositing of requisite fee @ Rs. 2/- per page by the appellant. Feeling aggrieved, the appellant approached the Commission.

Relevant facts emerging during hearing:

Appellant is absent despite notice. Respondent is present and heard. The respondent states that information spanning across 141 pages has already been furnished to the appellant. The appellant is stated to have raised an industrial dispute and the case is pending before labour court. The views of appellant qua his dissatisfaction could not be ascertained.

Decision:

After hearing the respondent and perusal of record, the Commission concludes that requisite information has already been given. No further action is warranted in the present appeal.

The appeal is disposed of.
