Information sought:

The appellant had sought information on following points:-

- i) Particulars of 06 finalist cadets (JD) of Hyderabad Group who participated in drill for IGC and 3 cadets who were kept as reserve.
- ii) Particulars of best cadet of Hyderabad Group
- iii) Photocopy of SOP/procedure on selection of best cadet (JD) of Hyderabad
- iv) Photocopy of convening order under which bd of officers were detailed to carry out screening/ selection of participants for the best cadet of Hyderabad NCC Gp.

- v) Photocopy of board proceedings and details of marks through which the best cadet of Hyderabad NCC Gp was selected.
- vi) Reason for not giving opportunities to the appellant's son and other eight cadets.
- vii) Particulars of best cadet (JD) of Andhra Pradesh NCC Dte
- viii) Photocopy of SOP/procedure on selection of best cadet (JD) of Andhra Pradesh NCC Dte.
- ix) Photocopy of convening order under which bd of officers were detailed to select the best cadet of Andhra Pradesh NCC Dte.
- x) Photocopy of board proceedings and details of marks through which the best cadet (JD) of Andhra Pradesh NCC Dte was selected.
- xi) Procedure to detail guest cadet by name by the HQ DG NCC Delhi.
- xii) Is any RD cert being awarded to the guest cadets.
- xiii) Bd proceedings under which the appellant's son did not qualify.
- xiv) Without participating in the drill how a candidate was selected as Andhra Pradesh Best Cadet.
- xv) Particulars of cadet (JD) who participated in the competition for selection of India's best cadet
- xvi) Reason for seeking documents from the appellant's son after the competition was over.

Grounds for Second Appeal

The CPIO did not provide the desired information.

Order

During the hearing, the respondent CPIO submitted that full information was provided vide their reply dated 25.03.2014 in connection with the RTI application dated 12.02.2014. The case may therefore be closed.

The appellant was not present to challenge the contention of the respondent PIO.

On perusal of the case record, it is seen that information provided was point wise and complete in all respect. Hence, no further action is warranted.

The matter stands closed.
