Information sought and background of the case:

Vide RTI application dated 07.01.2016, the appellant sought information with regard to supply of manpower, details of agencies, details of job with category, total sanctioned strength, details of service tax account, code no, ESIC Code no., EPG code no., month wise bill of each agency and other related information under 13 points. PIO via letter dated 02.04.2016 furnished information with regard to point No. 1 to 6. With regard to point No. 7 and 8, information has been denied being 3rd party information. Regarding information on point No.9, the appellant was advised that month wise bills can be seen in the office of Hospital with prior permission. Rest of the information was denied as it did not pertain to Kasturba Hospital. Being dissatisfied, the appellant filed an appeal. The FAA vide order dated 06.05.2016 directed the PIO to provide the complete information. Upon non receipt of any information despite directions of the FAA, the appellant approached the Commission.

Relevant facts emerging during hearing:

The Respondent appeared alone to the exclusion of the appellant. The Respondent has placed on record a written note dated 01.08.2017 which

reveals that all of the information as sought by the appellant and available or pertaining to the Respondent Hospital have been duly provided to the appellant.

Decision:

In view of submission of the Respondent, it is noted that information as available and pertaining to the Respondent have been already provided to the appellant. The appellant has not contested the information received. The Commission finds no reason to interfere with the case at hand.

The appeal is disposed of accordingly.
