**Information sought and background of the case:**

Vide RTI application dated 30.09.2015, the complainant sought information under 2 points regarding alleged unauthorized construction at C-13, Gali No. 3 Kotla Village, Near Mayur Vihar, Phase-1, Delhi-91. CPIO did not respond to the RTI application. The complainant preferred first appeal but the same remained unheard. Feeling aggrieved the complainant approached the Commission.

**Relevant facts emerging during hearing:**

Both the parties are present and heard. The complainant states to be aggrieved by the denial of information. The complainant states that no reply was ever received from the CPIO. Per contra, the respondent states that reply was furnished to the complainant on 23.11.2015 and places the relevant record before the Commission. A copy of the same is taken on record. It is

stated by the respondent that the reply could not be furnished within the stipulated time frame due to shortage of staff & time taken to scrutinize records.

**Decision:**

After hearing parties and perusal of record, the Commission finds that the RTI application was dealt with adequately. The respondent shall send a copy of reply dated 23.11.2015 to the complainant within one week of receipt of this order.

The complaint is disposed of accordingly.
