## **FACTS:**

- I. Vide RTI application dated **23.11.2011**, the appellant sought information on **sole issue**.
- II. CPIO, vide its response dated **28.12.2011 & 24.02.2012**, has provided the information to the Appellant.
- III. The First Appeal (FA) was filed on **07.01.2012**, as desired information not provided.
- IV. First Appellate Authority (FAA), vide its order dated **30.01.2012**, directed CPIO to provide the information to the Appellant.
- V. Grounds for the Second Appeal filed on **18.05.2012**, are contained in the Memorandum of Second Appeal.

## **HEARING**

Appellant opted to be absent despite of our due notice to him. Respondents appeared before the Commission personally and made the submissions at length.

## **DECISION**

During hearing of the case it is submitted by Shri Arun Prasad & CPIO, that the captioned Second Appeal is based upon appellant's earlier RTI application dated **23.11.2011**. It is further submitted by Shri Arun Prasad & CPIO, that this Hon. Commission has already taken up the appellant's earlier Second Appeal based on

appellant's RTI application dated 23.11.2011 dealt in file no. CIC/SS/A/2012/002867 & CIC/SS/A/2012/003349 on 18.06.2013 and passed it's speaking order on the same date.

- 2. The Commission has perused the nature of the issue as contained in appellant's present RTI application dated 23.11.2011 and appellant's earlier RTI application of same date and finds that both RTI applications are same. Not only this, the reply provided by the respondents, vide their same responses i.e. dated 28.12.2011 & 24.02.2012 and the orders passed by the learned FAA on 30.01.2012 in both FA filed by the appellant, are also same.
- 3. In view of the position above and in the circumstances of case, the Commission feels that it would be appropriate and even justified to dispose of the appellant's captioned second appeal in terms of its earlier order dated 18.06.2013 passed in the appellant's earlier second appeal based on appellant's same RTI application dated 23.11.2011. Thus, the appellant's instant second appeal is hereby disposed of in terms of Hon. CIC's earlier order dated 18.06.2013 passed in file no. CIC/SS/A/2012/002867 & CIC/SS/A/2012/003349.

The Appeal is disposed of accordingly.
