**Information sought**

This matter concerns an RTI application filed by the Appellant, seeking information on six points regarding the documents treated valid for marriage declaration and for ascertaining dependency of an employee in the Respondent organization.

**The CPIO reply**

The CPIO, vide letters dated 9.9.2015 and 23.9.2015, provided information on points Nos. 1 and 4 to the Appellant. In respect of the remaining points, he stated that the

information was awaited from the concerned section and the same would be provided on its receipt. Thereafter, vide his letter dated 21.10.2015, the CPIO provided information on Point Nos. 2, 3, 5 & 6.

### **Grounds of the First Appeal**

No information provided.

### **Order of the First Appellate Authority**

The FAA upheld the CPIO's replies.

### **Grounds of the Second Appeal**

Complete information not provided on point Nos. 1, 3, 4 and 5.

### **Relevant facts emerging during the Hearing, Discussion and Decision**

The Appellant was not present in spite of a written notice having been sent to him. The Respondents stated that the information sought at all the points of the RTI application was provided in two instalments on 9.9.2015 and 21.10.2015. Copies of the replies sent by the CPIO have been shown to us and we see no ground to interfere with the same.
