**Corrigendum dated 12.07.2017.**

1. The Commission has received a letter No. 8772/LS dated 01.07.2017 from Shri Sanjay Dhar, Registrar General of Hon'ble High Court of Jammu & Kashmir, regarding CIC notice dated 15.06.2017 for hearing in complaint No. CIC/CC/C/2015/000407. Vide the said letter , it has been brought to the notice of the Commission that “ Hon'ble Division Bench High Court of J&K by virtue of order dated 09-12-2016 has been pleased to direct that the operation and effect of the impugned order dated 21-10-2016 passed by the Chief Information Commissioner, CIC in the aforesaid appeal/complaint shall remain stayed. A certified copy of the order dated 09-12-2016 passed by the Hon'ble Division Bench, High Court of J&K in OWP No. 1732/2010 MP No. 01/2016 is enclosed herewith for information and compliance.”
2. That the stay order dated 09.12.2016 of Hon'ble High Court of Jammu & Kashmir is stated to have been sent to the Commission on 15.12.2016 by registered posts. However, the receipt record has not been found in the Registry of the Central Information Commission.
3. That the instant matters were earlier listed on 1<sup>st</sup> September, 2016. Separate orders were passed with directions to the respondent i.e. CPIO, High Court of Jammu & Kashmir, to be personally present

on the next date of hearing and give the complete position in respect of non supply of information and the issue of jurisdiction.

4. Both the matters were again listed for hearing on 21<sup>st</sup> October, 2016 and a combined decision was passed on 21.10.2016 with the directions to the respondent to provide the information to the appellant in context to his RTI application dated 13.04.2015. The matter was accordingly disposed of on merit.
5. That due to oversight, the copy of the combined order dated 21.10.2016 was not put in file of complaint No. CIC/CC/C/2015/000407, and also the order in the instant complaint have not been uploaded on the CIC website.
6. Although both the matters, on merit, had been disposed of by the Commission vide combined order dated 21.10.2016, however, due to oversight and inadvertently a fresh notice of hearing in complaint No. CIC/CC/C/2015/000407 was issued and again the Commission had passed adjunct order dated 04.07.2016.

**DECISION:**

7. Taking into account the aforesaid reasons, the Commission hereby orders that the notice dated 15.06.2017 and adjunct order dated 04.07.2017, passed in the complaint no. CIC/CC/C/2015/000407, of the Commission be considered as infructuous.

Copy of the order be given to the parties free of cost.
