ORDER

Facts:

1. The appellant filed RTI application dated 29.07.2015 seeking information on 2 points viz. (i) Basic pay + Grade pay of Mr. Vinod Kumar Shukla, Postman at Rewa Head Post office as on 01.01.2006 and 01.11.2011, and (ii) Basic pay + Grade pay of Mr. Deep Narayan Pandey, Sub-Postmaster at Rewa, Sub-Post office as on 01.01.2006 and 01.07.2015 along with their respective pay fixation sheets.
2. The CPIO responded on 24.08.2015. The appellant filed first appeal dated 30.09.2015. The FAA responded on 05.11.2015. The appellant filed second appeal on 23.12.2015 before the Commission on the ground that information should be provided to him.

Hearing:

3. Both the parties participated in the hearing through video conferencing.

4. The appellant stated that he should be provide the calculation sheet of Mr. Vinod Kumar Shukla and Mr. Deep Narayan Pandey as made out by the postal department on 01.01.2006, 01.11.2011 and 01.07.2015.

5. The respondent stated that they have drawn the calculation sheet of the pay fixation on 01.01.2006 in view of the 6th Pay Commission's recommendations and the DoPT order. The pay fixation was not required on 01.11.2011 and 01.07.2015. Therefore, they are unable to provide the calculation sheets of 01.11.2011 and 01.07.2015.

Discussion/ observation:

6. The respondent should provide to the appellant the calculation sheet of the pay fixation as drawn on 01.01.2006, within 15 days from the date of receipt of this order. The calculation sheets of 01.11.2011 and 01.07.2015, if available, should be given.

Decision:

7. The respondent is directed to take action as per para 6 above.

The appeal is disposed of. Copy of the order be given to the parties free of cost.
