These files contain appeals in respect of the RTI applications dated 19.5.2015, 30.7.2015 and 18.5.2015, filed by the Appellant, seeking information on various issues concerning certain loans granted to him by the bank. Not satisfied with the response of the Respondents, he has approached the CIC in second appeal in all the three cases.

2. The Appellant stated that the information, which was directed to be provided by the First Appellate Authority in all the three cases, has not been provided by the CPIO. The representative of the Respondents was unable to make any submission regarding the action taken on the orders of the FAA. In response to our query, he stated that Shri B. B. Chandana, Senior RM is the CPIO.

3. We have considered the records and the submissions of both the parties. With regard to the RTI application dated 19.5.2015 (File No. 71), we direct the CPIO to provide to the Appellant the specific information sought by him at points No. 1, 3, 4 and 5 of the application. Regarding the RTI application dated 30.7.2015 (File No. 86), the CPIO is directed to provide to the Appellant the statement of the account from 30.9.2007 to 11.4.2009 in response to points No. 1 to 4 of the RTI application. With regard to point No. 5, the CPIO should provide a copy of the relevant rules to the Appellant. As for the RTI application dated 18.5.2015 (File No. 302), the CPIO is directed to provide the information in response to all the six points of this application on the basis of the records of the bank. The CPIO should comply with our above directives, within twenty days of the receipt of this order, under intimation to the Commission. The information should be provided free of charge.

4. With the above directions and observations, the three appeals are disposed of.

5. Copies of this order be given free of cost to the parties.
