Information sought and background of the case:

The complainant vide RTI application dated 02.01.2015 sought information under 5 points primarily regarding rules framed by the Government of Puducherry in exercising the powers conferred u/s 30 of the Consumer Protection Act, 1986, rules framed by State Govt. for filing consumer complaint and powers & duties of Registrar as per the Consumer Protection Act, 1986. The CPIO, Dept, of Civil Supplies transferred the RTI application to CPIO, State Commission & Distict Forum, Puducherry on 04.01.2015. CPIO did not respond to the RTI application. Feeling aggrieved the appellant approached the Commission.

Relevant facts emerging during hearing:

The complainant is absent. The respondents are present and heard. The CPIO, Dept of Civil Supplied states that information relating to his department was furnished on 19.01.2015. The CPIO, State Consumer Commission states that remaining information was furnished vide reply dated 28.01.2015. He apprises the Commission that all the rules sought by the complainant were furnished.

Decision:

After hearing respondent and perusal of record, the Commission finds that the RI application in question has been dealt with adequately. No ground, as prayed for by the complainant is made out for exercising jurisdiction u/s 18 of the RTI Act, 2005

The complaint is dismissed.
