During the hearing the respondent CPIO submitted that they had provided the reply vide their letter dated 05.10.15 in connection with RTI application dated 11.09.2015. The appellant submitted that he got incomplete information.

On perusal of the case record, it is seen that information on point nos. 3 and 4 are not covered in the said reply.

The respondent CPIO is considered as nodal PIO and is directed to provide consolidated/point wise reply complete in all respect to the appellant as available on record including certified true copies of the documents e.g. note sheet, letters, correspondence, e.mail free of charge u/s 7(6) of the RTI Act within 21 days of the receipt of the order for this purpose, CPIO/PIO, may take assistance of any other office/department u/s 5(4) of the RTI Act.

The respondent CPIO is further directed to send a compliance report containing the copy of the reply and the despatch details within 07 days thereafter to the Commission for record.

With the above direction, the appeal is disposed of.
