**ORDER**

1. Shri Vijay Gahlawat filed an application dated 25.03.2015 under the Right to Information Act, 2005 (RTI Act) before the Public Information Officer (PIO), Police Headquarters (PHQ), Delhi seeking information on thirteen points regarding lists of all the civilian posts along with their basic pay, grade pay in

the computer cadre as well as the recruitment rules, basic pay, grade pay, educational qualification, salary etc. about two civilian posts i.e., Computer Centre supervisor and Programmer.

**2.** Shri Vijay Gahlawat filed a second appeal dated 06.07.2015 before the Commission on the grounds that satisfactory information has not been provided on all the points of his RTI application. The appellant requested the Commission to direct the CPIO to provide the information sought by him.

**Hearing:**

**3.** Both the appellant Shri Vijay Gahlawat and the respondents Shri H.M. Bakshi, ACP, Crime, Delhi Police and Shri Pancham Chand, ACP, Confidential Branch, PHQ, Delhi Police were present in person.

**4.** The appellant submitted that no information in respect of point nos. 2, 5 and 8 of his RTI application has been provided to him by the respondent. The appellant requested the Commission to direct the respondent to provide the information on the same to him.

**5.** The respondent (CPIO, PHQ, Establishment Division) submitted that point wise reply as per the records available in the respondent office has been provided to the appellant vide letter dated 28.04.2015. The respondent further submitted that the RTI application was further transferred under Section 6(3) of the RTI Act to CPIO, PHQ and CPIO, DCP, Crime, Delhi Police for furnishing the information which pertained to their office.

**6.** The respondent (CPIO, PHQ) in respect of point no. 1 of the RTI application submitted that on receipt of the RTI application from CPIO, PHQ, Establishment Division, the appellant was informed vide letter dated 17.04.2015 that copies of documents indicating pay scales of various posts of Delhi Police can be obtained on payment of the requisite fee. The respondent in

respect of point nos. 2 to 12 of the RTI application, submitted that the information sought relates to CPIO, PHQ, Establishment Division.

7. The respondent (CPIO, DCP Crime, Delhi Police) submitted that on receipt of the RTI application from CPIO, PHQ, Establishment Division, information in respect of point no. 7 of the RTI application has been provided to the appellant vide letter dated 26.05.2015. The respondent in respect of the remaining points of the RTI application submitted that the information sought cannot be provided as the same does not relate to the office concerned.

**Decision:**

8. The Commission, after hearing the submissions of both the parties and perusing the records, observes that complete information has not been provided to the appellant by the respondent. In view of this, the Commission directs the respondent (CPIO, PHQ, Establishment Division) to provide information on point nos. 2, 5 and 8 of the RTI application to the appellant, within a period of four weeks from the date of receipt of a copy of this order.

9. With the above observations, the appeal is disposed of.

10. Copy of the decision be provided free of cost to the parties.
