Information sought and background of the case:

Vide RTI application dated 22.01.2016, the complainant sought inspection of three letters authored by Under Secretary, CHS as addressed to Secretary, (H&FW) GNCT. CPIO did not respond to the RTI application. Feeling aggrieved the complainant approached the Commission.

Relevant facts emerging during hearing:

Both the parties are present and heard. The representative of complainant states that the complainant who is Professor, Dept. of Psychiatry, GB Pant Institute of Medical Education & Research and presently posted in IHBAS, Delhi is aggrieved being deprived of her salary for last 20 months. In this factual backdrop, the complaint is stated to have sought the information in

question. The CPIO, H & FW Dept. states that the RTI was forwarded to GB Pant Institute of Medical Education & Research being the custodian of information. The representative of complainant states that the CPIO, GB Pant Hospital did not facilitate inspection of the record. He desires to obtain information in form of inspection & certified copies. Acceding to his request, the present complaint is being taken up as appeal.

He further requests that the e-file relating to the salary of appellant may also be disclosed as it directly relates to query no. 1 of the RTI application. The CPIO voluntarily agrees for the same. The CPIO states that the authorities concerned at GB Pant Medical College & Hospital did not act on their numerous reminders on the issue in the past.

Decision:

After hearing parties and perusal of record, the Commission directs the CPIO, Dept. of Health & FW to collate the information sought and alongwith e-file and offer inspection of the records. Accordingly, the appellant or her authorized representative shall report to CPIO office at 9th Floor, Delhi Secretariat on 02.02.2017 at 11.30 am for carrying out the inspection. The appellant shall also be at liberty to take certified copies of records free of cost upto 25 pages.

The appeal is allowed accordingly.
