Information sought and background of the case:

Vide RTI application dated 02.02.2016, the complainant sought information:-

The status and action taken report by CVO, Garden Reach Shipbuilders and Engineers Ltd of the Vigilance Complaint No. 27670/2015/Vigilance(filed by the undersigned) which was sent to the CVO of Garden Reach Shipbuilders and Engineer Ltd., by CVC vide Memorandum dated 18.12.2015.Whether cognizance has been given & what actions has been taken against the errant officials of GRSE.	No information is available with this CPIO. However, your RTI application is being transferred to other CPIO as per Section 6(3) of the RTI Act, 2005 for providing the information directly to you.
4.	The status of my Vigilance Complaint dated 09.10.2015 addressed to the CVO, GRSE (Received by CVO on 10.10.15). Whether cognizance has been given & what actions has been taken against the errant officials of GRSE.	As above at point No. '3'

CPIO Ministry of Health & Family Welfare forwarded the RTI application to the CPIO, Garden Reach Shipbuilders Ltd., vide letter dated 16.02.2016 for furnishing reply to the query No. 3 & 4. Having not received any response from the CPIO of GRSE, the complainant approached the Commission.

Relevant facts emerging during hearing:

Complainant is absent despite notice. The respondent is present and heard. CPIO/GSRE states that point No. 3 and 4 of RTI application have been examined and found no merit. He further states that a reply has been furnished to the complainant. The complainant is not present to canvass his case.

Decision:

After hearing the respondent and perusal of record, the Commission finds that relevant information has already been furnished to the complainant.

The complaint is disposed of accordingly.
