FACTS:

- I. Vide RTI application dated **21.04.2016**, the Complainant sought information on **11 issues**.
- II. CPIO, response is not on record.
- III. The First Appeal (FA) was filed on **02.06.2016**, as desired information not provided.
- IV. First Appellate Authority (FAA), is not on record.
- V. Grounds for the Complaint filed on **18.07.2016**, are contained in the Memorandum of Complaint.

HEARING

Complainant opted to be absent despite of our due notice to him. Respondents appeared before the Commission personally and made the submissions at length.

DECISION

At the outset, it is to be seen here that the captioned Complaint is based upon Complainant's earlier RTI application dated **21.04.2016**. It is further to be seen here that this Hon. Commission has already taken up the complainant's earlier Complaint based on Complainant's RTI application dated **21.04.2016** dealt in file no. **CIC/KY/C/2016/000188 on 05.08.2016** and passed it's decision on the same date.

2. The Commission has perused the nature of the issues as contained in complainant's present RTI application dated **21.04.2016** and complainant's earlier RTI application of same date and finds that both RTI applications are same.

3. In view of the **position** above and in the **circumstances** of case, the Commission feels that it would be **appropriate and even justified** to dispose of the complainant's captioned complaint in terms of its earlier order dated **05.08.2016** passed in the complainant's earlier complaint based on complainant's same RTI application dated **21.04.2016**. Thus, the complainant's instant complaint is hereby disposed of in terms of Hon. CIC's earlier order dated **05.08.2016** passed in **file no. CIC/KY/C/2016/000188**.

The complaint is disposed of accordingly.
