FACTS:

- I. Vide RTI application dated **30.03.2012**, the appellant sought information on **4 issues**.
- II. CPIO, vide its response dated **25.04.2012 & 16.05.2012, 28.05.2012, 22.06.2012, 03.08.2012**, denied to provide the information being third party information.
- III. The First Appeal (FA) was filed on **09.08.2012**, as desired information not provided.
- IV. First Appellate Authority (FAA), vide its order dated **04.09.2012**, upheld the decision of CPIO.
- V. Grounds for the Second Appeal filed on **22.09.2012**, are contained in the Memorandum of Second Appeal.

HEARING

Appellant opted to be absent despite of our due notice to him. Respondents appeared before the Commission personally and made the submissions at length.

DECISION

It is pertinent to mention here that the appellant, vide his RTI Application dated **30.03.2012**, sought information from the respondents on **4 issues**. Respondents, vide their responses dated **25.04.2012 & 16.05.2012, 28.05.2012, 22.06.2012, 03.08.2012**, provided the required information to the appellant. Being aggrieved by the aforesaid response, FA

was filed by the appellant on **09.08.2012** before the FAA, who vide his order dated **04.09.2012**, upheld the decision of CPIO. Hence, a Second Appeal before this Commission. As such, the instant second appeal deserves to be dismissed in terms of Section 2(f) of the RTI Act 2005, alone.

2. Furthermore, as per the contents of appellant's hand written letter dated **07.04.2015**, appellant requested this Commission to allow him to withdraw his second appeal. However, appellant failed to highlight any reasons in this regard for the reasons best known to him.
3. In view of the above, the Commission finds **no legal hitch** in acceding to the appellant's request. Thus, the appellant's request is hereby acceded to and his second appeal is **dismissed as withdrawn**.

The Appeal is dismissed as withdrawn.
